RESOLUTION NO. 011/2017**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MONROE, WASHINGTON, DESIGNATING THE DAILY HERALD AS THE OFFICIAL NEWSPAPER OF THE CITY OF MONROE; AND AUTHORIZING THE MAYOR TO SIGN AN AGREEMENT FOR PROVISION OF OFFICIAL LEGAL NEWSPAPER SERVICES

WHEREAS, the City of Monroe is an optional municipal code city organized under the provisions of Title 35A; and

WHEREAS, RCW 35A.21.230 requires each code city to designate an official newspaper by resolution for the purpose of publishing ordinances and other notices required to be published by law; and

WHEREAS, the City of Monroe solicited proposals for an official newspaper through the competitive bidding process; and

WHEREAS, the City Council's preference is for a newspaper of daily distribution, in order to more efficiently process and publish required legal notices; and

WHEREAS, the City Council has determined that The Daily Herald is a newspaper of general circulation in the City of Monroe and has the qualifications prescribed by Chapter 65.16 RCW and RCW 35A.21.230 for official newspapers.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MONROE DOES RESOLVE AS FOLLOWS:

Section 1. Designation. The Daily Herald is hereby designated as the official newspaper of the City of Monroe, Washington, for the purpose of publishing ordinances and other notices required to be published by law.

Section 2. Approval of Agreement. The City Council approves the Agreement for an Official Legal Newspaper with The Daily Herald, in substantially the same form set forth in Exhibit A to this resolution. The Mayor's signatory authority set forth herein shall include the authority to negotiate revisions, as determined by the Mayor to be appropriate and reasonable, to the aforementioned documents.


Section 3. Effective Date. This resolution shall take effect immediately upon passage.

**AGREEMENT FOR OFFICIAL LEGAL NEWSPAPER  
BETWEEN CITY OF MONROE AND THE DAILY HERALD**

THIS AGREEMENT entered into this \_\_\_\_ day of \_\_\_\_\_, 2017, by and between the CITY OF MONROE, a municipal corporation organized under RCW Title 35A and THE DAILY HERALD.

The Daily Herald, a newspaper meeting the requirements of RCW 65.16.010 and RCW 65.16.040 and having a general circulation within the City of Monroe, is hereby designated as the City of Monroe official newspaper for the period commencing with the date hereof and ending December 31, 2017, with the City having the option to renew annually.

The Daily Herald agrees to publish all matters which shall be required by the City of Monroe during the term of this Agreement for and in consideration of \$1.38/line per column width of 2.236 inches for non-emergency publications first insertion; the sum of \$1.38/line per column width of 2.236 inches for non-emergency publications second and subsequent insertions; and the sum of \$1.38/line per column width of 2.236 inches for emergency publications first insertion.

Publication and deadline schedules shall for both emergency and regular publications shall be as set forth in Exhibit 1 submitted by The Daily Herald which schedules are incorporated herein. Exceptions will be when there must be an early deadline because of a holiday, in which case The Daily Herald will notify the City in advance.

The Daily Herald shall submit proof of publication an affidavit of publication for each matter published to the following:

The Daily Herald will republish at no extra charge to the City, any notice or other matter submitted by the City for publication in the event of any typographical or other error made on the part of the publisher.
