

**RESOLUTION 2012/008**

**A RESOLUTION ESTABLISHING PARKING RESTRICTIONS IN  
THE CITY OF MONROE AND REPEALING RESOLUTION 2008/024**

WHEREAS, the City of Monroe finds that it is in the public interest to establish parking restrictions in certain areas of Monroe; and,

WHEREAS, provisions for such limitation are made in Chapter 10.12 of the Monroe Municipal Code;

NOW, THEREFORE, IT IS HEREBY RESOLVED,

That Resolution 2008/024 is hereby repealed.

That parking shall be restricted, where not prohibited by other laws, rules, or regulations, and the following area designated as a bus zone between the hours of 8:00 A.M. and 6:00 P.M.

North Blakeley

East side: from 123 feet south of center line Hill Street to 193 feet south of center line Hill Street.

That parking shall be restricted, where not prohibited by other laws, rules, or regulations, to a maximum of 2 hours, between the hours of 8:00 A.M. and 5:00 P.M., except for weekends and holidays, in the following locations:

North Blakeley

West side: Main to 150 feet south of centerline of Hill

East side: Main to 230 feet south of centerline of Hill

That parking shall be restricted, where not prohibited by other laws, rules, or regulations, to a maximum of 2 hours, between the hours of 8:00 A.M. and 6:00 P.M., except Sundays, in the following locations,:

North Ferry

East side: Main to Hill

West side Main to Hill

South Ferry

West side Main to Alley

West Main

North side: Madison to Blakeley

North side: Lewis to Blakeley  
South side: Lewis to Blakeley  
South side: Blakeley to Fremont

East Main

North side: Ferry to Lewis  
South side: Ferry to Lewis

South Lewis

East side: Main to 220 feet south of the centerline of Fremont Street  
West side: 82 feet south of the centerline of Main to alley south of Main

North Lewis

East side: Main to Hill  
East side: Hill to Railroad tracks  
West side: Railroad tracks to Hill  
West side: Hill to 83 feet north of the centerline of Main

West Hill

North side: Blakeley to alley west of Blakeley

West Fremont

South side: Main to Alley west of Blakeley

That parking shall be restricted, where not prohibited by other laws, rules or regulations, and the following area designated as a loading zone:

Woods Street:

From 228 feet north of the centerline of Fremont Street to 158 feet north of the centerline of Fremont Street

That parking shall be restricted, where not prohibited by other laws, rules, or regulations, to a maximum of two hours, between the hours of 7:00 A.M. and 5:00 P.M., Monday through Friday in the following locations:

Village Way

Adjacent to the Monroe Branch Sno-Isle Regional Library

That parking shall be restricted, where not prohibited by other laws, rules, or regulations, to a maximum of 15 minutes in the following locations:

East Fremont

South side: Ferry to alley west of Ferry

South Lewis

West side: Main Street to 82 feet south of the centerline of Main

North Lewis

West side: Main Street to 83 feet north of the centerline of Main

That parking shall be prohibited, where not prohibited by other laws, rules, or regulations between the hours of 7:00 am and 4:00 pm Monday through Friday.

North Kelsey Street

East side: 170 feet south of centerline Hill Street to 335 feet south centerline of Hill Street

That parking shall be prohibited, where not prohibited by other laws, rules, or regulations between the hours of 8:00 am and 4:00 pm Monday through Friday.

Dickinson Street

East side: 65 feet south of centerline Park Lane to 500 feet south of centerline Park

West side: Dickinson to 130 feet south of centerline Park Lane

It is hereby further resolved that there will be No Parking at any time on

Frylands Boulevard to 167<sup>th</sup> Avenue

East side: Tye to 146<sup>th</sup> Street

West side: Tester Road to 230 feet south of the center line of Tester Road

169<sup>th</sup> Avenue

Tye to 146<sup>th</sup> Street

Tester Road

164<sup>th</sup> Street to City Limits

147<sup>th</sup> Street

179<sup>th</sup> Avenue to Tye Street

Beaton Road

Tye Street to 169th Avenue

179th Avenue

Oaks Street

Frylands Boulevard

North Kelsey

SR 2 to Chain Lake Road

West side: SR 2 to Main Street

South Kelsey

West side: Main Street to Pike Street

South Lewis

West side: 130 feet south of the centerline of Sumac Drive south to Monroe City Limits

East side: Sumac Drive south to Monroe City Limits

West side: 508 feet south of centerline of McDougall Street to 590 feet south of the centerline of McDougall Street

East side: 462 feet south of centerline of McDougall Street to 519 feet south of the centerline of McDougall Street

Dickinson Street

West side: 130 feet south of centerline Park Lane to 500 feet south of centerline Park

East side: Dickinson to 65 feet south of centerline Park Lane

Village Way

Inside of loop

Elizabeth Street

North side: 350 feet east of the centerline of Kelsey to 470 feet east of the centerline of Kelsey Street

Blueberry Lane

South side: 300 feet west of Kelsey Street

North side: 65 feet east of Driveway to 18621 Blueberry Lane

Currie Road

South side: Frylands Boulevard to the east edge of Lord's Lake Division 2

Kirby Drive

West side: West Main Street to 340 feet north of centerline of West Main Street

Kirby Drive

East side: West Main Street to 340 feet north of centerline of West Main Street

West Hill Street

South side: Madison to Alley between Madison and Blakeley

It is hereby further resolved that there will be No Parking at any time, except Sundays and holidays on

167<sup>th</sup> Avenue


West side: Tye to 146<sup>th</sup> Street

It is hereby further resolved that said restrictions on parking shall continue to be in full force and effect until such time as the Council directs otherwise.

This resolution will be effective the 6<sup>th</sup> day of March 2012.
