ORDINANCE NO. 012/2024

AN ORDINANCE OF THE CITY OF MONROE, WASHINGTON,
AMENDING CHAPTER 2.04 MMC COUNCIL MEETINGS AMENDING
THE REGULAR MEETING DAYS FOR THE MONROE CITY COUNCIL;
PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN
EFFECTIVE DATE.

WHEREAS, pursuant Chapter 2.04 of the Monroe Municipal Code (MMC), the City has established regular days for meetings of the Monroe City Council; and

WHEREAS, the City Council desires to amend its regular meeting schedule to remove the first Tuesday of each month as a regular meeting;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MONROE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Amendment of MMC 2.04.010. Section 2.04.010 of the Monroe Municipal Code is hereby amended to provide in its entirety as follows:

2.04.010 Regular meeting date established.

The city council shall hold its regular meetings on the ~~first~~ second through fourth Tuesdays of each month at the hour of seven p.m. The city council may limit the scope of its regular meetings, such as designating some of them “study sessions,” in its by-laws or other rules of procedure.

Section 2. Legislative Intent; Superseding Effect. It is the express intent of the Monroe City Council that the amended meeting days set forth in Section 1 of this ordinance shall supersede: (i) any and all inconsistent provisions of the MMC, and (ii) any and all inconsistent provisions of any rule, order, or protocol adopted by City Council.

Section 3. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 4. Effective Date. This ordinance shall be in full force and effect five (5) days from and after its passage and approval and publication as required by law.
