**METER RENTAL FEE: \$20.00, Per Week**

**METER DEPOSIT OF \_\_\_\_\_ \$225.00 for 3/4" or \_\_\_\_\_ \$1900.00 for 3" meter with DCVA.**

The customer is responsible for maintaining the required amount of deposit at all times while the equipment is checked out. The City will bill monthly for water consumption used during your rental of the meter. The charge for water is over and above the meter deposit.

Failure to pay water charges, maintain deposit level or maintain or return equipment may result in:

- Repossession of the meter by the City of Monroe;
- Forfeiture of deposit; and
- Legal action to recover water charges and/or cost of equipment.

**\*\*NOTE:** Replacement costs for damage to or loss of, or failure to return meter will be billed at the current replacement cost for all equipment checked out to renter. Cross connection control consisting of air gap, reduced pressure backflow assembly or double check valve assembly shall be used at all times. Renter shall comply with MMC Ch. 13.06.

As of January 4<sup>th</sup>, 2014 Section 1417 of the Safe Drinking Water Act prohibits the use of any pipe or plumbing fixture (i.e. hydrant meters) that is not made lead free to be used for the distribution of human consumption. Unless specified the hydrant meter being rented is for non-potable uses only. Violation of this policy will result in repossession of the hydrant meter and the forfeiture of the deposit.
