

**AMENDMENT No. 5 TO COMPREHENSIVE GARBAGE, RECYCLABLES AND YARD DEBRIS
COLLECTION CONTRACT**

This Amendment (the "Amendment") No. 5 to the Contract is entered into as of the 1st day of January 2024 (the "Effective Date"), by and between Rabanco, Ltd. dba Republic Services of Bellevue ("Contractor"), and City of Monroe (the "City") (collectively referred to herein as the "Parties" and individually as a "Party").

WHEREAS, the Parties entered into the Comprehensive Garbage, Recyclables and Yard Debris Collection Contract (hereinafter "Contract") for collection and disposal or recycling services dated 1st January, 2017.

AND WHEREAS, the Parties desire to amend certain terms of the Contract which shall take effect from 1st January, 2024.

NOW, THEREFORE, in consideration of the above premises and of the mutual covenants herein contained and other consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned Parties agree as follows:

1. Except as specifically provided in this Amendment, each and every provision of the Contract and previously executed amendments, if any, between the Parties remain, and is, in all respects, in full force and effect.
